## SIGNIFICANT ACCOUNTING POLICIES

- vi) Taxes on Income: The Society is complying with provisions of Section 11 & 12 of the Income Tax Act, 1961 and as such the income of the Society is exempt from income tax underand accordingly no provision for tax is required.
